



International Student Confidential Financial Statement

Furman University requires verification of adequate finances from applicants with or applying for F-1 visas. A student must be prepared to pay tuition and fees, as well as all costs for off-campus living expenses at the beginning of each quarter. If, upon arrival at the university, you do not have the required funds indicated below, it will be necessary for Furman to notify the U.S. Department of Homeland Security that you have failed to meet the requirements for a student visa.
